MAIL-O-GRAPHIC TOURNAMENT RULES

1. The National Women's 500 Club, Inc., for its members, will conduct this tournament.
2. An entrant must be a current member of USBC. She must also be a member of the National 500 Club or may join when her entry is submitted. A bowler may enter by including her \$15.00 lifetime membership dues and **application** with her tournament entry fee.
3. The deadline for submitting entries is February 6, 2025.
4. This tournament will be conducted by submitting USBC certified league scores bowled during the two-week time frame of February 9 through February 22, 2025. Entrants will use their current highest certified league average as of date of participation based on a minimum of 12 games in the league from which they are submitting scores. All others will use a 210 average.
5. This tournament will be handicapped at 90% of 210. USBC rule 319A-2 (10 pin increase provision) will not apply. 319d (tournament prize winning provision) and 319e (tournament average adjustment) will not apply. USBC rule 319a-3 (reporting incorrect average will apply).
6. If more than three games are bowled in scheduled league play, the first three games will be used. Traveling leagues bowling six games (two 3-game series) may be entered for either series or both series. Entering both would be two entries and as such would require two entry fees. An entry fee may be submitted for each USBC certified league in which the participant is bowling. If you want to use the scores from more than one league each league entry would constitute a separate entry and additional entry fees would be due.
7. Each entry will be randomly paired with another when all scores have been submitted. The two bowlers combined scores with tournament handicaps will equal their total score.
8. All scores must be bowled in a USBC certified league. Scores bowled in mixed leagues are eligible for this tournament. The prize fund will be returned 100% and will be based on at least one cash award for every five entries. The highest doubles handicapped score bowled in 3 games will be declared Champions. In case of a tie for first place, the club may declare Co-Champions with first and second place money divided equally between the two duplicate awards.
9. Photocopies of the recap sheet or computer-generated score sheets will be accepted. Scores can be sent via email attachment to 500bowl@gmail.com or mailed with a post-mark no later than March 8, 2025 (close of tournament).
10. No refunds for entry fees will be issued.
11. Payout will be within 30 days from the close of the tournament.
